WHAT IS A SKILLED WORKER VISA? A skilled worker visa allows you to enter the UK to work. The visa

permits you to be employed in an eligible job with an approved employer.

To qualify for a Skilled Worker visa, you must:

- be paid a minimum salary how much depends on the type of work you do

• £26,200 per year

- £10.75 per hour
- the 'going rate' for the type of work you'll be doing
- Your employer must make sure your job pays at least the minimum

wage and follows the rules for how many hours a week you can work. If your employer does not do this, your application will be refused. CHECK IF YOUR JOB IS ELIGIBLE

The certificate of sponsorship is an electronic record, not a physical document. It will have a reference number, which you'll need for your visa application.

You must apply for your visa within 3 months of getting your certificate of sponsorship.

When making the application, you must show that you can support yourself when you arrive in the UK - you'll usually need to have at least £1,270 available in your bank account which has been held for

Should you not have these funds, then your employer may be able to make a declaration that they will cover your costs.
