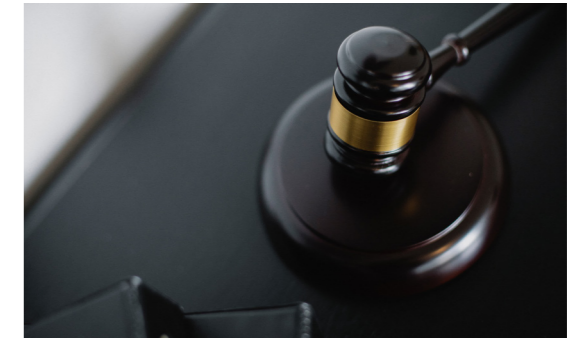

Felix is fluent in English, Italian and Ibo.

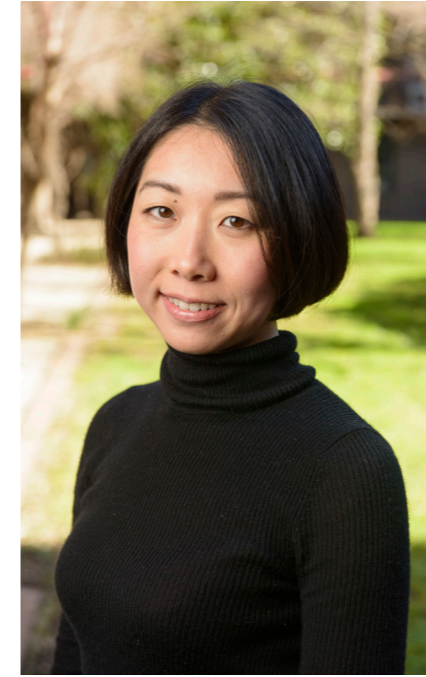


Xinlei Zhang

Xinlei is fluent in English and Mandarin Chinese.

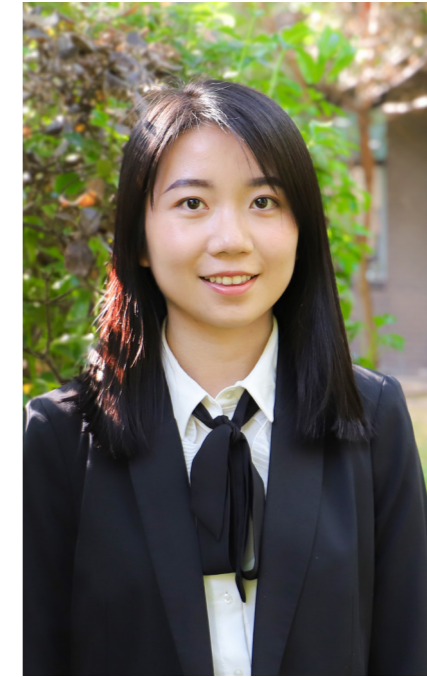


Yitong Guo
