Mahfuz speaks English and Bengali.

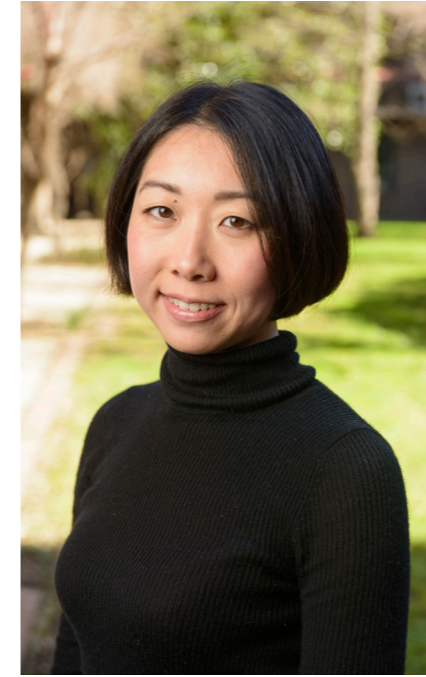


**Mingyan Gao**

Xinru speaks fluent Mandarin and English.

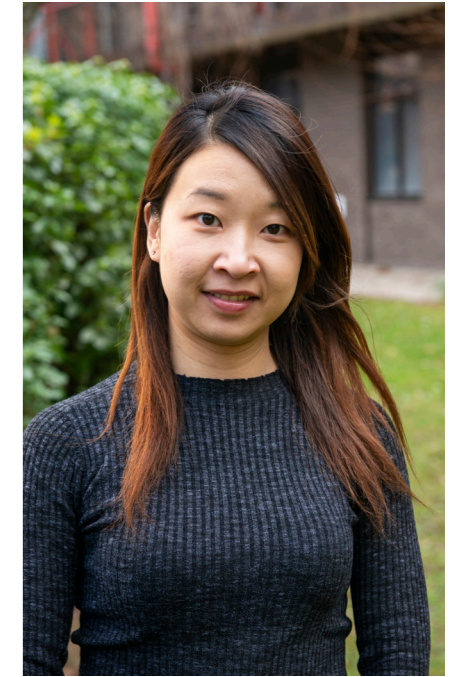


**Xinjia Xie**

Zeyu has previous experience in China of providing legal services in a local court as well as for a law firm.

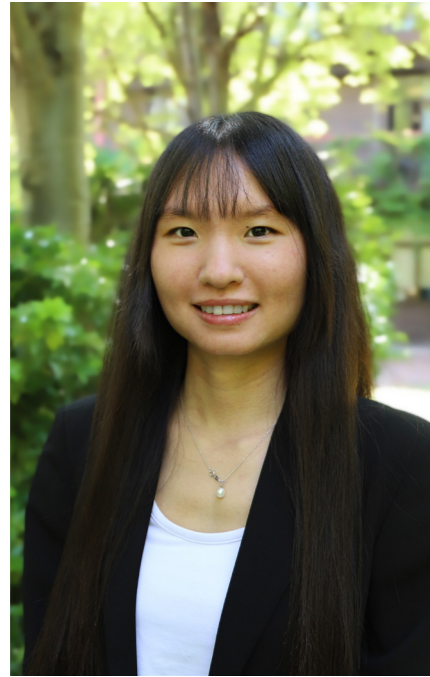

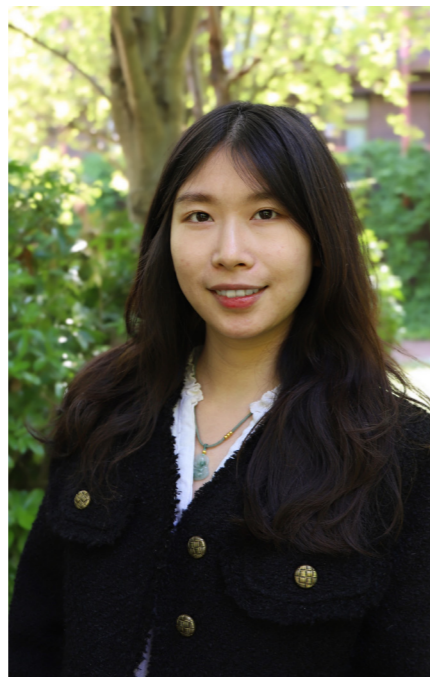
Charlotte is multilingual, with fluency in a range of languages including Cantonese, Mandarin and English. This enables her to communicate with a wide variety of clients.
